The Shahid Javed Burki Scholarship Program

The Shahid Javed Burki Institute of Public Policy at NetSol (BIPP) has instituted “The Shahid Javed Burki Scholarship Program” (SJBSP) for female students based on need and merit to help them realize their career objectives, contribute to achieving the national development objectives and play their overall societal role as enlightened citizens of Pakistan to serve the humanity.

I. SCOPE OF THE SCHOLARSHIP PROGRAM

All undergraduate female students to be enrolled from the fall session 2022 for the following programs/disciplines offered by their respective Universities are eligible for the SJBSP:

- Fatima Jinnah Medical University (MBBS)
- Lahore College for Women University (BSCS, BSSE, BSME, D Pharmacy)
- University of Lahore (Bs. Nursing)

II. WHAT ARE THE SCHOLARSHIP DETAILS?

Amount: Semester Fee for 8 to 10 semester and 5 year MBBS

Deadline: September 09, 2022

Awarded: _____

The scholarship is available for the completion of the entire degree program subject to the condition that the scholarship awardee should score minimum 3.0 GPA in each semester and in case of MBBS minimum 60% marks in each prof to continue to receive the scholarship.

III. APPLICATION DEADLINE

All applications must be submitted by September 09, 2022 (closes at Midnight, Pakistan Time) by filling online application form given on BIPP’s website. The winner will be selected and notified via email.

IV. ADDITIONAL SCHOLARSHIP DETAILS:

1. Limit of one application per person will be strictly observed.
2. Winning candidate will be selected through a competitive process based on well-defined merit cum need criteria by the Scholarship Committee;
3. The scholarship is available on semester basis and is renewable subject to satisfactory performance (minimum 3.0 GPA in each semester, 60% marks in case of MBBS) till the completion of the degree program;
4. Scholarship funds will be sent by cross cheque to the Institute or University towards payment of semester Tuition Fee for the current academic year.

V. SCHOLARSHIP AWARD RULES

Subject in each case to the terms and conditions set forth in these Rules (“Rules”), BIPP will award at least 50 scholarships each year in the amount of semester Fee applicable by the Institute or University (timed to coincide with the beginning of a typical Institute/University Fall semester 2022).

(a) ELIGIBILITY

Female legal residents of Pakistan who are eighteen years of age or older at the time of applying and who are to be enrolled in the above-mentioned Institutes (see first page) are eligible to apply for the scholarship.

Void where prohibited by law.

Do not submit an application if you do not agree to the terms and conditions of these Rules.

(b) HOW TO APPLY FOR THE SCHOLARSHIP

Applicants will complete the scholarship form given on BIPP’s website (www.sjbipp.org), submit the contact information (name, email, etc.), and upload their attested scanned documents with the form.

Applicant will provide proof of enrollment in the Universities identified for SJBSP, a transcript, tuition receipt, or acceptance letter.

All applications, including all content, become the property of BIPP and will not be returned. The content included in applications may be used in marketing materials or posted on the BIPP website without further compensation or notice to the applicant. In no event shall BIPP be liable for any potential recipient notification that is lost, intercepted, or not received for any reason.

By submitting an application, the candidate fully and unconditionally accepts and agrees to these Rules. The decisions of BIPP, shall be final and binding.

(c) PROCESS OF SELECTION FOR POTENTIAL SCHOLARSHIP WINNERS

BIPP will select the potential awardees of scholarship based on the prescribed need cum merit base criteria and will give due weight to creativity, ability, originality and clarity of the career goals. A committee constituted by BIPP will select potential recipients. The potential winners will be obligated to supply proof of enrollment in the Institute or university indicated in the application before any award is given. The potential winners will be notified via private message through social media or email. BIPP will not be liable for any potential recipient notification that is lost, intercepted, or not received by the potential recipient for any reason.

(d) PAYMENT OF SCHOLARSHIP AWARD

The selected winner(s) will receive a Scholarship Award in the amount of Semester Fee payable through crossed Cheque directly to university where she is enrolled, once the Scholarship Awarded Recipient has enrolled and submitted proof of enrollment to BIPP.

Awarded Recipient must submit proof of enrollment for the current semester. Scholarship Awards may not be assigned, transferred, or changed, except at the sole discretion of BIPP.

No cash equivalent Scholarship Awards will be awarded.

The awarding of any Scholarship is contingent upon full compliance with these Rules.

Applicants agree to be bound by Rules and agree that if any Scholarship Awarded Recipient fails to respond to electronic communication within ten (10) calendar days, provide proof of identity, refuses to provide required affidavit, refuses to complete and provide any requested information, is found to have violated the Rules, or does not meet eligibility criteria, Scholarship Award will be forfeited and the Applicant who submitted the Application with the next highest score will become an alternate potential Scholarship Awarded Recipient.

Applicants understand that BIPP is not liable for injuries, losses, or damages of any kind arising from participation in this Scholarship Program and acceptance, possession, and use of Scholarship Award.

BIPP is not responsible for any typographical or other error in the printing of the offer, administration of the Scholarship Program, or in the announcement of the Scholarship Award.

(e) PRIVACY

By submitting the application, the candidate acknowledges that BIPP and its related units may contact the applicant in relation to the scholarship.

(f) PUBLICITY

Except where prohibited by law, by accepting a scholarship award from BIPP, the recipient agrees that BIPP may, without any limitation or further compensation or notice, use his or her name, voice, and/or likeness in any and all media, worldwide, for the purpose of advertising and promoting BIPP mandate and/or its services, or the Scholarship program. The recipient also agrees to provide an image or portrait of themselves to be posted on the BIPP website as the winner of the scholarship award.

(g) OWNERSHIP OF CONTENT

By submitting the application, the candidate acknowledges and agrees that: (a) BIPP will own the application, including essay and any images that candidate links to in the application, and (b) as between the candidate and BIPP, BIPP will own all publishing rights in and to the Application and the written response submission.

Each Applicant hereby irrevocably grants, transfers, sells, assigns and conveys to BIPP, its successors and assigns, all present and future rights, titles and interests of every kind and nature, including and without limitation, all copyrights, and all rights incidental, subsidiary, ancillary, or allied thereto (including and without limitation, all derivative rights) in and to the Application and the written response submission(s) and linked media for use in perpetuity, by means of any and all media and devices whether now known or hereafter devised (the "Rights"). BIPP shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter, the Application and the content of submission(s) for any purpose which BIPP deems necessary or desirable, and each Applicant irrevocably waives any and all so-called moral rights they may have in the Application and written response submission(s) submitted by her. Each Applicant hereby acknowledges that such Applicant does not reserve any rights in and to the Application and the content of submission(s).

(h) DISPUTE RESOLUTION

Applicant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Scholarship Program, or awarding of the Scholarship Awards, shall be resolved individually, without resort to any form of class action; and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in this Scholarship Program but in no event attorney fees; and (c) under no circumstances will any participant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

(i) REPRESENTATIONS AND WARRANTIES/INDEMNIFICATION

Each person who enters this Scholarship Program represents and warrants to BIPP as follows:

- i. The Application, including the content, is the Applicant's own original, previously unpublished, and previously unused work;
- ii. The content/ submission is wholly original with Applicant and as of the date of submission, is not the subject of any actual or threatened litigation or claim;
- iii. The submission neither infringes upon nor violates the intellectual property rights or other rights of any other person or entity;
- iv. The submission does not and will not violate any applicable laws, and meets the Submission Requirements set forth above.
- v. Each Applicant hereby agrees to indemnify and hold BIPP harmless from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs, and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations, or agreements of Applicant hereunder.

(j) FURTHER DOCUMENTATION

Except where prohibited, potential Scholarship Awarded Recipients (or their parents or legal guardians if they are minors at the time of application) will be required to complete and return an Affidavit of Eligibility and compliance of Rules within ten (10) days of notification or the Applicant with the Application with the next highest score will become an alternate potential Scholarship Award Recipient. If notification to a potential Scholarship Award Recipient is returned as undeliverable, the Applicant with the Application with the next highest score may become an alternate potential Scholarship Award Recipient

(k) GENERAL RELEASE AND LIMITATIONS ON LIABILITY

By entering the Scholarship Program, each Applicant acknowledges and agrees that BIPP and its employees, officers, directors, and representatives are not responsible for any costs, injuries, losses, or damages of any kind arising from or in connection with:

- (i) incomplete, lost, late, misdirected or illegible entries or for failure to receive Applications due to any cause, including without limitation human, transmission, or technical problems, failures, or malfunctions of any kind, whether originating with sender, or otherwise, that may limit an Applicant's ability to participate in the Scholarship Program; or
- (ii) any injury or damage resulting, directly or indirectly, in whole or in part, from participation in the Scholarship Program and/or the use of any Scholarship Award,

including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to, loss or destruction of property, or any claims, costs, injuries, losses, or damages related to or based on the Applicant's rights of publicity or privacy, or the Applicant's claim that he or she has somehow been defamed or portrayed in a false light. BIPP assumes no responsibility for any damage to an Applicant's computer system which is occasioned by accessing the Website or participating in the Scholarship Program, or for any computer system, phone line, hardware, software, program malfunctions, or other errors, failures, delayed computer transmissions, or network connections that are human or technical in nature, or for the incorrect or inaccurate capture of information, or the failure to capture any information. This scholarship program is subject to all Pakistan federal, provincial and local laws and regulations. Void where prohibited by law.

(l) BIPP RIGHT TO MODIFY, SUSPEND, OR TERMINATE

In the event BIPP is prevented from continuing with the Scholarship Program by any event beyond its reasonable control, then BIPP shall have the right in its sole discretion to modify, suspend, or terminate the Scholarship Program.

(m) GENERAL PROVISIONS

BIPP reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the application process or the operation of the Scholarship Program or the Website, to be acting in violation of these Rules, to be submitting responses dishonestly or inaccurately, or to be acting in an unsportsmanlike or disruptive manner. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. The authorized account holder is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. If an Application is confirmed by BIPP to have been erroneously deleted, lost, or destroyed, the entrant's sole remedy shall be another Application, if time permits. BIPP's failure to enforce any term of these Rules shall not constitute a waiver of that or of any other provision.
